Dispatch Cost Apportionment Calculation

I. Policy:

Each calendar year end (December 31st) CAL Fire Administration shall supply JPA Administration with the ECC workload report. This is a 4 column spreadsheet that breaks down the ECC work effort (See Exhibit A). The JPA appropriation is determined by subtracting each El Dorado County Fire District share from the 100% in column 4. Each Fire District's appropriation is the percentage in column 4. The JPA shall then invoice each member District's quarterly share based on the previous calendar year numbers (i.e. for the calendar year 2008 the split was 84.938% JPA and 15.062% Fire Districts as shown in Exhibit A).

II. Purpose:

The purpose of this policy is to establish the procedure for cost apportionment between the JPA and member Districts for Dispatch Services.
